 - 17 overdoses 2023 YTD: 9 total for 2022

Discussion:

- TruNarc (analysis tool) Purchased
 - Analyzes drugs – safer testing for evidence tech
 - Seeing Meth mixed with Fentanyl to make more addicting
 - Can perform 35 analysis tests per year now
 - Local police departments being notified to send to Sheriff's office
 - Process being developed
 - Couple of officers have been trained on how to use
 - Lori to see if she can allocate funding for more tests
- Jail CASAC is doing well
