### **How do I determine which figures to use in calculating my Taxes?**

- ~ Consult the latest Final Assessment Roll listing for your property. You will want to note the Fire District code, Lighting District code and any Water and/or Sewer District codes (and the number of units listed for the Water/Sewer districts).
  - ~ On the rate chart use the "Inside" figures if you are in the Village limits.
  - ~ Use the "Outside" figures if you are not in the Village limits and there are no Special District Codes
  - ~ All other properties will need to find the rate line that is correct for their Fire/Lighting districts.
  - ~\*Note that not all properties with a Fire District will have a Lighting District also.
  - ~ Use the figures for any Water/Sewer Districts which may be applicable to your property. Most are a flat rate (per unit charge)
  - ~To calculate taxes, take the total assessed value of the property, divide by 1000, then multiply by the appropriate tax rate.
- Example - Owego property in fire district 002 and lighting district 002 with a total assessed value of \$120,000  
 - 120,000/1000 is 120, times tax rate of 21.334174 = \$2,560.10
